The Samahan sa Pilipinas ng mga Industriyang Kimika (SPIK) recently hosted its 3rd Chemical Industry Night at the Citadines Bay City in Manila. The event, themed "Driving Sustainability and Partnerships Toward Progress," brought together business leaders, chemical industry associations, academe, professional organizations, and government partners to celebrate and bolster the sector's commitment to responsible and sustainable practices.

















The evening's highlight was the signing of the Declaration to the Responsible Care Global Charter by thirty SPIK member companies, signifying their dedication to the highest safety, health, and environmental standards. This collective pledge underscores the industry's commitment to the responsible management of chemicals and their contributions to sustainable development.

Commitment on behalf of the signatories,
reaffirming their intent to integrate
Responsible Care principles into their

The event alo saw the launch of SPIK's unique and enhanced **Responsible Care logo**, designed by 18-year-old senior high school student Anna Mikaela Benitez. The new logo reflects the association's renewed focus on global Responsible Care initiative and in driving safety and sustainability, in line with the International Council of Chemical Associations' (ICCA) updated guidelines.



Meanwhile, Mr. Ronaldo DC Buluran, Director of the Board of Investments' Manufacturing Industries, recognized the chemical manufacturing sector's substantial contribution to the country's GDP and applauded SPIK's efforts in the implementation of the Philippine Chemical Industry Roadmap.

Notably, Atlantic Coatings, Inc., JG Summit Olefins Corporation, Mabuhay Vinyl Corporation, and Pacific Paint (Boysen) Philippines, Inc., were honored with commemorative plaques for their consistent annual submissions over a five-year period.



Following the awarding ceremony, Engr. Albert A. Samuela, the Vice President for External Affairs, presented a comprehensive update titled "Philippine Chemical Industry Roadmap: Strategic Updates and Growth Imperatives for a Thriving Future." Throughout his presentation, Engr. Samuela highlighted the ongoing efforts of the Small Working Groups, which are working towards the realization of the PCIR's seven key strategies.



SPIK also launched the Human Reliability Program (HRP) Manual, a project funded by the Health Security Partners (HSP) in 2023. This manual is a significant tool for advancing chemical security within the industry. Engr. Ma. Arlene V. Ramirez of Dow Chemical Philippines Inc., Mr. Pio Ramirez, and Engr. Gretchen F. Enarle of Atlantic Coatings, Inc., were recognized as key contributors to the HRP Manual. Their work is vital in ensuring the industry's continuous improvement in safety and security standards.

The event concluded with closing remarks by Engr. Dennis G. Tirthdas, Director and SPIK Ways and Means Committee Chairman. Following the successful night, the SPIK Golf Tournament took place at the Manila Golf and Country Club, serving as an excellent networking opportunity for the chemical industry's key stakeholders.

### SPIK JOINS PH-CWC MEETING TO STRENGTHEN CHEMICAL INDUSTRY COMPLIANCE




The Samahan sa Pilipinas ng mga Industriyang Kimika (SPIK), with President **Engr. Gretchen F. Enarle** at the helm, recently attended an introductory meeting concerning the implementation of the Chemical Weapons Convention (CWC). As a significant player in the chemical sector, SPIK's presence underscored the importance of collaboration in ensuring national security and environmental safety.

The gathering, which included representatives from the Philippine CBRN Team and partners from the US Department of State's ISN-Cooperative Threat Reduction (CTR), Health Security Partners (HSP), and Defense Threat Reduction Agency (DTRA), aimed to foster a robust exchange of knowledge and strategies post-CWC ratification. The discussion focused on SPIK's role in providing essential data on chemicals under CWC purview, thereby enhancing the nation's commitment to the treaty.



The event marked the beginning of a series of engagements to bolster the chemical industry's adherence to international regulations and reinforce the Philippines' stance against chemical warfare.

### SPIK & ACC Collaborate on Responsible Care Workshop Agenda



The upcoming Responsible Care Verification Workshop saw a preparatory meeting between the Samahan sa Pilipinas ng mga Industriyang Kimika (SPIK) and the American Chemistry Council (ACC). Engr. Gretchen F. Enarle, SPIK President, and Engr. Reinier Jay C. Bagabay, SPIK Responsible Care

Director, met with Mr. Dan Roczniak, ACC's Senior Director for Responsible Care.

The meeting's primary objective was to finalize the workshop's agenda, which is set to take place in November. This collaboration underscores both associations' commitment to advancing responsible and sustainable practices within the chemical industry. The workshop aims to enhance participant knowledge and ensure compliance with international standards, thereby fostering a safer and more environmentally conscious industry in the Philippines.

### SPIK-PIChE Partnership Progresses with Strategic Collaboration Meeting



On October 17, 2024, the Samahan sa Pilipinas ng mga Industriyang (SPIK) and the Philippine Institute of Chemical Engineers (PIChE) held a collaboration meeting to strategize the execution of projects aligned with the Memorandum of Understanding (MOU) signed in June. This partnership aims to strengthen the local chemical industry's growth through knowledge sharing and joint initiatives.

Key figures from both organizations participated the meeting: PIChE was represented by Dr. Josephine Borja, Dr. Vergel Bungay, and Engr. Elen Perlado, while SPIK was composed of Engr. Gretchen F. Enarle, SPIK President, Engr. Albert Samuela, VP for External Affairs, and Engr. Arnold Benitez, VP for Internal Affairs.

The alliance has several webinars in the pipeline, such as the PIChE Registry and PCIR Roadshow in December, which will serve to educate and engage the professional community. Furthermore, a GHS Webinar is scheduled for February 2025 to promote awareness and compliance with the Globally Harmonized System of Classification and Labeling of Chemicals. In March 2025, the focus shifts to Responsible Care (RC) Awareness, emphasizing the importance of environmental, health, safety, and security practices within the industry.

### SPIK and Saltegra Consulting Strengthen Ties Through Process Safety Initiatives







## ARCP Workshop 2024: Enhancing Regional Chemical Management and Circular Economy



The ARCP Workshop 2024, a significant event focused on advancing chemical management policies and practices, was held at Melia Hanoi Hotel, Vietnam, on October 28-29, 2024. The conference featured a series of regulatory dialogues and technical sessions aimed at fostering collaboration and knowledge sharing among governments and industries in the ASEAN region.

Day 1 commenced with the first Regulatory Dialogue Session on Chemical Management Policy, where speakers discussed the management of Confidential Business Information during the inwards clearance process. This was followed by presentations from Indonesia, the APEC Chemical Dialogue, and the Philippines on various topics such as the Stockholm Convention on Persistent Organic Pollutants, online registration for hazardous substances, and updates on policies for impurities and CBI.

The second session on the same day involved discussions on the Circular Economy and the implementation of Extended Producer Responsibility (EPR). Governments from Malaysia, Thailand, Philippines, and Vietnam shared their EPR implementation strategies and challenges.

Day 2 of the workshop was dedicated to technical topics, including an introduction to the Chemical Risk Assessment (CRA) Voluntary Work Group and the ARCP CRA Guidance Document. This session provided a foundation in toxicology, eco-toxicology, and environmental exposure risk assessment. Jeff Li and Sue May Teoh from the Data Sharing/Management NSN VWG discussed New Substance Notification, emphasizing data sharing and management practices.

The Globally Harmonized System (GHS) was another highlight of the workshop. Attendees received updates on the ARCP GHS VWG and APEC CD GHS VWG and were presented with a summary of GHS version 10. Furthermore, Cissie Yeung shared industry practices for SDS quality, check, and assurance, emphasizing the importance of reliable and consistent information for chemical handling and safety.

The ARCP Workshop 2024 underscored the commitment of the ASEAN countries to work towards a planet free from harmful chemicals and waste, with the Global Framework on Chemicals serving as a guiding force. The event also marked the first anniversary of the Global Framework on Chemicals' adoption and announced the opening of the Global Framework on Chemicals Fund's first application round.

The conference, attended by Engr. Joy Pena of the SPIK Responsible Care Council, facilitated open dialogues and collaborations, contributing to the strengthening of chemical policies and practices in the region, and promoting a more sustainable and safer environment.
