ReCAP 2025: Advancing Responsible Care Practices in the Philippine Chemical Industry



The Responsible Care Awareness in the Philippines (ReCAP) program, a partnership between the Samahan sa Pilipinas ng mga Industriyang Kimika (SPIK) and the Philippine Institute of Chemical Engineers (PIChE) conducted another successful session on May 27, 2025, at the PTTC in Pasay City. This was a work to develop environmental, health, and safety awareness of the chemical industry

The training session was opened with a thought -provoking opening message from Dr. Nathaniel Dugos, PIChE's National President and highlighted that the call to promote environmental and human welfare should be addressed at all operational levels.

In her presentation, **Engr. Gretchen F. Enarle,** SPIK President, provided a comprehensive overview of the Responsible Care program. She elaborated on the Pollution Prevention and Distribution Codes of Management Practices, stressing the need for rigorous pollution control measures and an efficient supply chain that enhances safety and security. She highlighted the significance of a proactive approach to environmental



**Ms Janet Marcella**, Technical Manager of Shell Pilipinas Corporation, presented the Security Code, which was essential adding complete security measures against theft and sabotage. She addressed the importance of risk assessments and the need for good procedures in managing sensitive materials.



Process Safety and Employee Health and Safety Codes, presented by **Mr. Lian Derick Layog**, Country Health, Safety, Security, Sustainability and Environment Manager of DKSH Philippines, Inc., focused on the regular upgrading of workplace environment and practices. He said that to prevent accidents, regular audits and training of staff was required along with conformity with the international standards.



The Product Stewardship Code was presented by **Ms.**Joy Pena, Senior Product Regulatory Specialist of Dow Chemical Philippines. She spoke on the need for responsible product design, manufacture and disposal to avoid damaging people and the environment. She also emphasized the importance of openness in revealing materials and of early involvement with stakeholders in a product's life-cycle.



Engr. Albert Samuela's, Marketing Director of Nalco Philippines-an Ecolab Company, take on the Community Awareness and Emergency Response (CAER) Code echoed the need for planning and working with local populations to best handle a crisis. He pushed for communicating and sharing in emergencies.



The 15 participants found the training session to be timely and relevant from various sectors, manufacturing, warehousing, trading and logistics providers. The detailed preparations of the SPIK-PIChE Technical Working Group, consisting of Dr. Josephine Borja, Dr. Vergel Bungay, Engr. Elen Perlado of PIChE, and Engr. Arnold Benitez, Engr. Gretchen F. Enarle, Engr. Reinier Bagabay, and Ms. Antonette Fallarme of SPIK ensured a seamless and informative experience for all participants.


# SPIK Engages in DTI-Led FGD to Fortify Tatak Pinoy Strategies

The local chemical industry, through the Samahan sa Pilipinas ng mga Industriyang Kimika (SPIK, actively took part in a Focus Group Discussion (FGD) of the Department of Trade and Industry (DTI) on May 5, 2025. It was a partnership that sought to draw up industry profile and product strategies to push through with the Tatak Pinoy initiative, a law signed to strengthen the competitiveness of local industries.



Mr. Karl Lyndon B. Pacolor, Officer-in-Charge Assistant Director of the Bureau of Policy Research and Innovation of the DTI, opened the session emphasizing the need for actual business data for improving the country's industrial policy. Dr. Annette Pelkmans-Balaoing facilitated the discussions across five key themes: competitive despite cost disadvantages, driving innovation and technological innovation, building strong

local sourcing and value networks, forming strong partnerships and strategic alliances, and securing government support and policy recommendations. Based on the combined experiences of the petrochemical, plastic and chemical industries, the participants involved towards a more open exchange on issues and best practices, and the later could provide important insights into the definition of future policy interventions.



### SPIK Shares Insights on Chemical Industry Growth and Importation Regulations at SEIPI Purchasing Managers' GMM



SPIK was invited to be a Resource Speaker at the Association of SEIPI Purchasing Managers' (ASPM) Q2 General Membership Meeting (GMM). Held on 13 May 2025 at Gruppo EMS, Inc. in Laguna Technopark, Philippines, the session featured discussion on the availability and production capacities of the chemical local market; and the trade regulatory issues on importation; and how trade wars affected the supply chain.

In her presentation, **Engr. SPIK President Gretchen F. Enarle** spoke about the state of the chemical industry today and the problems and potential solutions for electronics and semiconductor firms trying to comply with regulations. She added: "It's also essential to keep abreast of the latest importation rules to ensure you stay ahead of the game."







GMM also had **Mr. Charlie Villaseñor**, Chairman of the Procurement and Supply Institute of Asia (PASIA) discussing supply chain management in the age of trade wars and AI, and **Engr. Jomar R Montalvo**, Country Sales Manager of Ellsworth Adhesives Philippines Inc., who discussed their complete end-to-end chemical importation, warehousing, and distribution solutions offered at Ellsworth. Mr. Raymund Chua, Chairperson of ASPM, presented the status of their projects and priorities.



Following the informative sessions, attendees had the opportunity to explore the latest products and electronic accessories through a plant tour and supplier showcase. The event aimed to foster collaboration and knowledge-sharing within the industry, ultimately supporting its continued growth and innovation.




## Strengthening Chemical Security in Indonesian Industry: SPIK Shares Insights





Mr. Daniel Roczniak of the American Chemistry Council (ACC) also graced the event, sharing insights on the successful integration of Responsible Care in the U.S.





# ASEAN Regulatory Cooperation Platform (ARCP) Conducts Successful Mini Webinars on Chemical Management in 2025



In this context, also Dunja Drmač, senior manager at the European Chemical Industry Council, offered insights on "Simplification of REACH- perspectives from the chemical industry".




# Hazard Identification and Controls Webinar: Enhancing Process Safety in the Chemical Industry






