ASCEND Focus Group Discussion: Promoting Industry-Academe JUL4 Partnership in Research



The focus group discussion took place on July 4, 2025 at the UPLB Technology Transfer and Business Development Office (TTBDO), during which the ASCEND Program Team convened discussions with UPLB TTBDO representatives. The main objective of the meeting is to collect comments and invaluable experiences with respect to the proposed framework for industry-academe collaboration under ASCEND project.



The attendees included Engr. Albert Samuela of Samahan sa Pilipinas ng mga Industriyang Kimika (SPIK), Ms. June Villasanta and Ms. Geraldine Buela, of the Board of Investments (BOI), and Ms. Cathrene Amante and Ms. Maria Elaidia C. Barria-Briones of UPLB TTBDO, under the guidance of Dr. Emil the TTBDO Cabrera. Director. The conversation centred on how best to work together to effectively connect academic research with industry challenges to create lasting impact and sustainability in a sector as vital as chemicals.

The strategic meeting was held to enhance the ASCEND initiative ensuring its continued success and relevance in the future.

SPIK, BOI, DOST-ITDI and DLSU Convene to Discuss Procedural JUL9 Clarifications on R&D Funding



In a strategic partnership, the Samahan sa Pilipinas ng mga Industriyang Kimika (SPIK), Board of Investments (BOI), De La Salle University (DLSU) and the Department of Science and Technology Industrial Technology Development Institute (DOST ITDI) conducted a Small Group Discussion and Stakeholders Consultation on July 9, 2025. Engr. Albert Samuela, Vice President of SPIK, facilitated the session.

The goal of the meeting is to clarify the procedural steps and timelines for submitting new projects to DOST—particularly ITDI—for research and development work and government funding endorsement. The team aims to assess how this funding route aligns with the project's development timeline, including submission schedules, approval periods, and release of funds. A realistic evaluation is needed to determine whether DOST funding can support the intended project milestones. If timelines are misaligned and would delay implementation, the



SPIK Holds Successful 7th Board Meeting: Strategizes for International Events and



The board reported on its significant participation at the AMEICC in Malaysia, APRCC in Indonesia and the Asian Chemicals Forum in India, as well as the ARCP event in Manila, co-organized with the Global Silicones Council and the Board of Investments. This global engagement is a source of pride for our community.

Another topic in the agenda was the SERIC and RC Committees' future schedule, including in-person and webinar activities. One eagerly anticipated item ended the proceedings an announcement of a bowling tournament in July. Public Consultation On the Basel Ban Amendment

The Environmental Management Bureau's (EMB) Hazardous Waste Management Section (HWMS) organized an important online public consultation on Basel Ban Amendments last July 25, 2025. Led by Engr. Irvin Cadavona, OIC, Chief of HWMS, the meeting brought together experts from industry, government, academia, and non-government organizations. This joint session was meant to exchange views and fine-tune the Philippine position towards the global banning of hazardous waste exports to developing countries, a pillar for inclusion in the Basel Convention.

The Consultation is just the beginning of a Hazardous Waste Roadmap 2030 for the country. A follow-up Inception Workshop scheduled for August 08 is expected to pull together these insights to put the country's stance on the Amendment in its final form. This move represents a government in touch with its stakeholders and the environment. It emphasizes commitment to sustainable waste management practices, which will in turn pave the way for safer, healthier lives amongst Filipino people.



RESPONSIBLE CARE (RC) COUNCIL STRENGTHENS INDUSTRY STEWARDSHIP AND CAPACITY BUILDING



The Responsible Care (RC) Council convened virtually on July 30, 2025, gathering key member companies to align on current initiatives and set forward-looking priorities under the RC program, in alignment with Strategy 5 of the Philippine Chemical Industry Roadmap (PCIR). The discussions emphasized strengthening industry compliance, enhancing verification protocols, and fostering continuous

improvement in line with Responsible Care principles.

Key updates included upcoming training for RC verifiers, verification processes, and deeper engagement with regulatory agencies such as the PNP-FEO, DDB, and DENR-EMB to support chemical safety and regulatory alignment. The also outlined upcoming Council capacity-building activities such as virtual RC awareness sessions, a coastal cleanup initiative, and other stakeholder engagement efforts designed reinforce environmental stewardship and industry collaboration.

The meeting reaffirmed the Council's commitment to Responsible Care through the active participation of member companies and the SPIK Secretariat.

PUBLIC CONSULTATION MEETING ON THE INTERNATIONAL NEGOTIATING COMMITTEE 5.2 MEETING







In an attempt to reach consensus on a treaty to resolve the plague of plastic pollution, Philippines 'Environmental Management Bureau (EMB) held a public consultation on the fifth session of Intergovernmental Conference INC 5.2 Meeting. The event took place at the Crowne Plaza Hotel on July 30, 2025, attended by representatives from various sectors including government agencies, non-governmental organizations, industry organizations including the Samahan sa Pilipinas ng mga Industriyang Kimika (SPIK) and academic institutions.

The meeting was meant to solicit opinions and suggestions on the proposed binding international legal instrument for mitigating global plastic pollution crises. Conversations during the event were lively, with members of various sectors coming up with sector-specific problems they faced as well as potential strategies to weave into the Philippines 'negotiation position. The meeting strengthened the importance of working together from all levels and professions, so as to formulate policies that align with the local landscape. This public consultation is a crucial part of shaping our country's response to an imminent international agreement.
